By-law Enforcement Complaints

The Municipality of Trent Hills has experienced significant growth in the last number of years. As a result; the number of property standards and by-law enforcement complaints received annually has steadily increased placing additional strain on our enforcement resources. In an attempt to better track the type of complaints and assist with prioritizing the volume of work the Municipality has determined that a modified written complaint filing system is warranted.

Now that the Municipality of Trent Hills has adopted a written complaint policy, this is how each complaint will be categorized.

For Instance;

Class 1 – Complaints that are a public health, safety or property damage implication or where the risk to humans or dogs exists. These examples would include but not limited too unfenced swimming pools, Property Standards Health & Safety Concerns, unsafe or faulty stairs/floors, Dog Attacks. Class 1 violations are considered paramount and receive first priority for enforcement.

Class 2 or Class 3 violations are less serious infractions that do not pose an immediate hazard to person(s) or property. These include things like zoning infractions, long grass and weeds, garbage or rubbish on properties, abandoned or inoperative vehicles and other yard and maintenance issues. Complaints regarding Class 2 or 3 violations are required to be received by the Municipality of Trent Hills in writing. They can either be completed on the complaint form available at the Municipal Office, on the Trent Hills website or by a separate letter sent or directly delivered to the Municipal Office.
